1. 新世纪检验认证有限责任公司相关机构及所属分支机构的说明

新世纪检验认证有限责任公司(以下简称: BCC)因资产关系和管理隶属关系,与以下组织构成了认可规范中所界定的相关机构。The following organizations constitute BCC Inc. related bodies defined in accreditation regulations due to assets relations and management subordinate relationship.

1.1 BCC 相关机构定义 Definition of BCC related body

BCC 相关机构是指与 BCC 有共同的所有者或董事、合同关系、同一个名称、非正式合作谅解备忘录或其它关系而使得对其评定结果有非常重要的利害或潜在影响的认证/审定/核查结果的能力。BCC's related body is one which is linked to BCC by common ownership in whole or part, common directors, contractual arrangement, a common name, informal understanding or other means such that the related body has a vested interest in any certification decision or has a potential ability to influence the process.

1.2 相关机构的评价和控制(见附表1、2) Evaluation and Control of related bodies (See Appendix 1, 2)

经 BCC 公正性委员会对 BCC 相关机构的活动进行评价,认为其目前所开展的活动不对 BCC 目前所开展的认证审核业务、审定与核查业务的公正性、独立性构成影响。同时,为确 保 BCC 认证审核、审定与核查业务持续保持公正和独立, BCC 将对这些相关机构的业务变 化情况进行及时跟踪和分析,并采取相应措施。Upon analysis of above related bodies' activities, the BCC Impartiality Committee believes that their activities current will not affect business impartiality and independence of BCC certification audit. At the same time, to ensure continual impartiality and independence, BCC will track and analyze the business changes of these related bodies in a timely manner and take corresponding measures.
